VII. Discussion

A. Schedule Codes in CurricUNET

- a. Gabrielle Stanco commented on Banner code changes being implemented to better distinguish classes being scheduled via asynchronous online instruction (schedule code 72) and synchronous online instruction (schedule code 71). The code updates will make reporting for CCCCO MIS and the California Virtual College more accurate.

- b. Committee discussed reviewing these code changes with the campus Curriculum Committees and potentially updating the DE addendum template to reflect this code distinction in the future.
- c. The Banner code changes will be implemented for fall 2023 scheduling.
