IX. Discussion

A. Fullerton College's AA GE Revision Update

The Fullerton College (FC) Curriculum Chair informed the committee of the campus's decision to adopt a 7-courses in 6-areas model to align with the State's minimum requirements ("Title 5 only"). This decision follows majority votes in favor from both the FC Curriculum Committee and the FC Academic Senate. As the revised GE pattern did not make it to the DCCC agenda today, no action was taken by DCCC.

B. Curriculum Platform (See curriculum and Instruction Technical Map)

The committee continued discussing the adoption of a new curriculum management inventory tool. Feedback from each campus included:

Fullerton College (FC): Emphasized the urgency to adopt a new platform to prepare for the Common Course Numbering project.

North Orange Continuing Education (NOCE): Suggested revisiting the discussion in the Fall when a new Curriculum Chair will be in place.

Cypress College (CC): Proposed waiting until the Fall to create a voting group template for each campus to implement.
