MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE NORTH ORANGE COUNTY COMMUNITY COLLEGE DISTRICT

September 27, 2016

The Board of Trustees of the North Orange County Community College District met for its Regular Meeting on Tuesday, September 27, 2016, at 5:30 p.m. in the Anaheim Campus Board Room.

Board President Barbara Dunsheath called the meeting to order at 5:30 p.m. and led the Pledge of Allegiance to the Flag.

B. **Sabbatical Reports**: The following sabbatical leave reports were also presented as part of the Chancellor's Report:

"Our Backyard Geology in Orange County": **Richard Lozinsky**, Fullerton College Instructor, presented an overview of his sabbatical research which included a study of Orange County's climate, population, rocks, plate tectonic setting, earthquake hazards, geologic history, fossils, hills, coastal changes, and future trends. Dr. Lozinsky noted that his sabbatical provided him the opportunity to travel to remote areas to collect samples to curate, visit facilities and local community colleges that cover Orange County geology, and complete the third edition of Our Backyard Geology in Orange County California.

<u>"The Nexus Between Caregiver Fatigue and Burnout in the Workplace"</u>: **Virgil Adams**, Cypress College Instructor, examined the impact of stress and burnout on the quality of client care provided by health care professionals, and how it occurs in health services. His study identified the detrimental outcomes associated with positive and negative stressors, and the cognitive and emotional reactions

that can lead to burnout of health care professionals who fail to monitor self-care, which can result in early retirements and health issues. His findings concluded that while there is no formula for predicting stress in the workplace, there is a need for further training for those in the health services field in order to provide better quality care and maintain their own well-being.

C. Chancellor Cheryl Marshall reported on her attendance at a meeting of Los Angeles and Orange County region CEOs to approve a governance structure for the new Workforce Development Initiative, the welcome reception hosted by Fullerton College in her honor, and on Cypress College being honored by the California Community Colleges Board of Governors for their efforts in energy conservation. She noted her plans to attend Fullerton College Psychology Day on September 30 and the Cypress College Legacy Scholars event on October 3.

- B. **Adam Gottdank** reported that Bob Simpson will be honored at the upcoming California Association for Postsecondary Education and Disability (CAPED) Convention as Administrator of the Year, and also noted that the District's AEBG consortium will once again be featured at the convention.
- C. **Bryan Seiling** noted that Regina Rhymes is slated to receive a diversity award from the Academic Senate for California Community Colleges (ASCCC), and also reported on a special Cypress College Academic Senate meeting where great strides were made towards their Distance Education plan.
- D. **Pete Snyder** reported on Fullerton College's on-going work on accreditation efforts, and also noted that their football team remains undefeated and is currently ranked third in Southern California.
- E. **Tina Johannsen** reported on her involvement in the ASCCC Standards and Practices Committee and stated that the first United Faculty Representatives Council Meeting would take place on September 27.
- F. **Rod Lusch** said that the CSEA is actively engaged in phone banking and canvassing efforts related to Proposition 55, and announced that CSEA has endorsed Leonard Lahtinen for the District 1 seat on the Anaheim City Council.
- G. **Kent Stevenson** thanked those who attended the Adjunct Faculty United mixer on September 16. He also reported that AdFac had concluded salary negotiations with the District and awaited a ratification vote by its membership.
- H. **Student Trustee Tanya Washington** reported on her attendance at the Legacy Program's Mentor/Mentee Dinner, the Tri-City Women's Conference, and a tour of the Cal State University, Fullerton campus.
- I. **Student Trustee Scott Begneski** expressed his gratitude to Vice Chancellor Fred Williams for attending the Fullerton College football game and announced that the Horticulture department's annual plant sale would take place on October 1-2.
- J. **Trustee Stephen T. Blount** reported on his attendance at the Adjunct Faculty United welcome back event, and thanked AdFac for hosting it.
- K. **Trustee Molly McClanahan** commended Karen Cant and Albert Miranda for their efforts to reduce waste and energy consumption at the Cypress College campus, and the Office of Public Affairs for publishing their District-wide email newsletter.
- L. **Trustee Jacqueline Rodarte** reported on her attendance at the Orange County Community Colleges Legislative Task Force meeting and the District's Retirement Board meeting.

- M. **Trustee Leonard Lahtinen** commented on the Capital Projects Report distributed to Board members, and recognized Ed Lopez, Trustee Area 2 candidate, for his attendance at the Board meeting.
- N. **Trustee Barbara Dunsheath** noted it was Voter Registration Day and urged everyone to encourage students to register to vote, and referenced "How to Hire for Diversity," an article which appeared in *The Chronicle*. She also shared that the Cypress College Foundation's annual golf tournament is on October 3 and that planning is underway for the Americana Awards on March 4, 2017.

Item 3.a: By block vote, the Board ratified purchase order numbers P0109648-P0112523 through September 1, 2016, totaling \$2,345,708.16, and check numbers C0043991-C0044094, totaling \$470,299.94; check numbers F0204087-F0204874, totaling \$1,027,664.41; check numbers Q0005085-Q0005118, totaling \$1,212.00; check numbers 88455023-88455793, totaling \$5,722,132.55; check numbers V0031386-V0031392, totaling \$14,718.00; check numbers 70076557-70076763, totaling \$33,773.31; and disbursements E8646874-E8654037, totaling \$7,160,613.55, through August 31, 2016.

Item 3.b: By block vote, authorization was granted to amend the contract with McMurray Stern and increase the contract amount by \$4,515 from \$349,750 to \$354,265, plus taxes, if any.

Further authorization was granted for the District Director, Purchasing, to execute the agreement on behalf of the District.

Item 3.c: By block vote, the Board of Trustees approved the donation of (2) surplus therapeutic equipment to Cypress High School.

Item 3.d: It was moved by Trustee Leonard Lahtinen and seconded by Trustee Stephen T. Blount to authorize the transfer of \$70,660,076.53 plus accumulated interest from the District's Retiree Benefit Fund to the District's Irrevocable Trust, administered by Keenan & Associates and the FUTURIS Public Entity Investment Trust Program.

Subsequent to the Board expressing their thanks to all who agreed to set up the District's Irrevocable Trust, the motion carried with Trustees Blount, Brown, Dunsheath, Lahtinen, McClanahan, Ontiveros, and Rodarte voting yes, including Student Trustees Begneski and Washington's advisory votes.

INSTRUCTIONAL RESOURCES

Item 4.a: The Board received as information the North Orange County Community College District Student Success Scorecard 2016 information which included a

presentation by Carlos Ayon, Fullerton College Director of Institutional Research and Planning; Phil Dykstra, Cypress College Director of Institutional Research and Planning; Tina King, School of Continuing Education Director of Institutional Research and Planning; and Brian Stern; District Senior Research and Planning Analyst.

The presentation included an analysis of a 2009-10 cohort of first-time students over six years which compared college data from one-time period to another, and a comparison with the statewide average in eight different college-level indicators, as well as completion date by race ethnicity. The indicators included: 1) persistence in three consecutive terms; 2) percent of students who earned at least 30 units; 3) completion – degree, certificate, or transfer; 4) Basic Skills Math completion; 5) Basic Skills English completion; 6) Basic Skills ESL completion; 7) Career Technical Education (CTE) award completion; and 8) skills builder – median earnings change. Also, included was an overall analysis of the School of Continuing Education performance indicators for Career Development and College Preparation (CDCP) progress and achievement rate since Scorecard data only captures one noncredit indicator.

While the overall findings reflect that both Cypress College and Fullerton College exceeded the statewide average in seven categories, the number of completers for both Colleges is still lower than the top performing community colleges in the State and nation. At Cypress College, in both Basic Skills English and Math completion, Native American and Pacific Islander students' achievement is significantly lower than white students, while Asian and Filipino student achievement is significantly higher. At Fullerton College, African American, Latino and Pacific Islander student achievement is significantly lower than white students in Basic Skills Math; in Basic Skills English, African American and Latino students' achievement is significantly lower than white students. Almost no achievement gap exists at both colleges in CTE.

In the ensuing question and answer period, the research team fielded questions related to the size of the cohort groups used in the findings; what information can be learned from the data; how the data is used to influence student success practices; and the role of State allocated funds designed to address the achievement gap.

Chancellor Marshall also noted that local results which are unreported at the state-level will be presented to the Board of Trustees in spring 2017.
