#### Additional Information

August 22, 2023 Board Meeting

The following additional information was provided regarding the August 22 Board meeting agenda:

Item 3.a, Public Hearing and Resolution Authorizing the Dedication of an Easement to Southern California Edison for Cypress College Charging Stations:

1. What is ten percent of the District's qualified electorate? Based upon the District's redistricting 2020, the voter age population was 586,743. Without hiring a demographer, we would estimate that 10% would be between 58,000 and 59,000. To date, we have not received any written protests.

# Item 4.d, Amendment to the Agreement with Westbergwhite Architecture for Fullerton College Building 300 Renovation:

1. Are these renovations for general safety and/or usability or for more specific uses? If they are for specific uses and since architectural changes are being done anyway in this amendment, should there be a pause now to consider whether any changes to the plans are needed in light of the new realities of oncampus vs. remote classes, etc.? These are safety and code requirements, which have been tentatively approved, pending finalization of these items. As of August 21, we have received approval from the State Chancellor's Office and Department of Finance to proceed to bid for this project. Time is of the essence, and we do not have time to pause, since this is a state funded project.

## Item 4.e, Amendment to the Agreement with OCTA and Fullerton College:

1. What data do we have on ridership by our students? Fullerton College receives ridership reports directly from OCTA to monitor student bus boardings by month. For the 22-23 academic year, OCTA documented a total of 164,143 boardings in comparison to a total of 68,098 boardings during the 21-22 academic year. The annual boarding decrease we experienced during the 20-21 and 21-22 academic years can be attributed to the impact of the COVID-19 pandemic. However, student utilization of the OCTA bus program is now on the rise as the 22-23 boarding data are the highest, we have seen during the four-year partnership.

Attached is the Cypress College annual ridership report. Cypress College ridership is significantly lower than Fullerton College mainly because Cypress College only has two routes (the Valley View route and Lincoln route) near the Cypress campus while the Fullerton campus is next to a main transportation hub. However, Cypress College students are accessing services across Orange County and ridership has grown significantly.

## Item 4.f, Fullerton College Study Abroad Out-of-Country Travel:

Do we seek student input on the Study Abroad locations? Yes, student input is solicited in a variety
of ways. They are engaged during tabling and special events on campus, at orientations, and
through pre- and post-program surveys. Broader reports from students nationwide through
reports such as the Institute of International Education (IIE)'s "Open Doors" report, etc. are also
used.




